

General Title & Registration Requirements

Georgia Resident/With a Recently Purchased Vehicle

From a Casual Sale (Person to Person or Business to Person)

- Completed Title (Seller, Buyer, Required Signatures, Date of Sale and Odometer Reading sections must be complete)
- Completed Title Application (Form MV-1)
Please note: All buyers on the title must sign the title application
- Georgia Driver's License or Georgia Identification
- Other State-Issued Driver's License
- U. S. issued passport
- Proof of GA Insurance
- GA Emission Inspection (if applicable)
- Proof of Fulton County residency if applicable
- Legible copy of driver's license and notarized Power of Attorney from any owner who will not be present at the time of registration
- Cash, Check or Money Order

Georgia Resident/With a Recently Purchased Vehicle

From a Dealership Sale

- Title receipt from recently purchased vehicle (*receipt is normally mailed to your home*)
- Georgia Driver's License or Georgia Identification
- Other State-Issued Driver's License
- U. S. issued passport
- Proof of GA Insurance
- GA Emission Inspection (if applicable)
- Proof of Fulton County residency if applicable
- Legible copy of driver's license and notarized Power of Attorney from any owner who will not be present at the time of registration
- Cash, Check or Money Order
- ***If vehicle is purchased from an out of state dealership or business sales tax may be due and payable before registration of vehicle***

New to Georgia Resident – with Title

- Original title issued in your name
- Current/Last Registration
- Georgia Driver's License or Georgia Identification
- Other State-Issued Driver's License
- U. S. issued passport
- Proof of GA Insurance
- GA Emission Inspection (if applicable)
- Current Mileage/Odometer reading
- Proof of non-residency
- Legible copy of driver's license and notarized Power of Attorney from any owner who will not be present at the time of registration
- Cash, Check or Money Order

New to Georgia Resident – without Title

Lien Holder, other Security Interest or Leased Vehicle

- T-17 Form, Affidavit of Title Held by Lienholder, Security Interest Holder or Leasing Company
- Loan Agreement with complete name and address of lien holder, if applicable
- Lease Agreement, if applicable
- Current registration
- Georgia Driver's License or Georgia Identification
- Other State-Issued Driver's License
- U. S. issued passport
- Proof of GA Insurance
- GA Emission Inspection (if applicable)
- Current Mileage/Odometer reading
- Proof of non-residency
- Legible copy of driver's license and notarized Power of Attorney from any owner who will not be present at the time of registration
- Cash, Check or Money Order

Leased Vehicle

- Photocopy of GA title in Leasing Company's name or validated copy of title receipt
- Copy of Lease Agreement
- Original Motor Vehicle Power of Attorney (from Leasing Company)
- Current registration, if applicable
- Georgia Driver's License or Georgia Identification
- Other State-Issued Driver's License
- U. S. issued passport
- Proof of GA Insurance
- Georgia Emission (if applicable)
- Current Mileage

Non Titled Vehicles

Please note:

- Vehicle model year 1985 or older do not require a title
- Boat Trailers, home made trailers and trailers weighing 2,000 lbs or less
- Vehicles not manufactured for highway use

In order to register a non title vehicle you will need

- Copy of current registration
- Bill of Sale
- Completed Form T-22B Certification of Inspection
- Georgia Driver's License or Georgia Identification
- Other State-Issued Driver's License
- U. S. issued passport
- Proof of GA Insurance
- Current mileage, if applicable
